

ORDINANCE NO. 2026-01

AN ORDINANCE AMENDING CHAPTERS 7 (TRAFFIC) AND 7A (TRAFFIC SCHEDULES) TO REVISE DAYTIME TIME-LIMITED PARKING AND EVENING RESIDENTIAL PARKING ON CERTAIN STREETS

WHEREAS, the Borough Council wishes to revise daytime time-limited parking and evening residential parking on certain streets in the Borough of Flemington as found in Chapters 7 (Traffic) and 7A (Traffic Schedules) of the Borough's municipal code; and

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Flemington, in the County of Hunterdon, State of New Jersey, that Chapters 7 and 7A shall be amended to include new sections as follows:

SECTION I.

Section 7-4.18 is hereby created and entitled "Residential Permit Parking Only During Certain Hours On Certain Streets" (all text novel):

During certain hours, no person shall park a vehicle upon any of the streets or parts of streets described in Schedule XXIII of Chapter 7A unless:

- a. The vehicle is owned or operated on a regular basis by a resident of the street on which such vehicle is parked and the vehicle displays on its driver's side rear window a current residential parking permit in such a manner as to be clearly visible; or
- b. The vehicle is owned or operated by a person visiting a resident of the street on which the vehicle is parked and the vehicle displays a current visitor parking permit issued to such resident; or
- c. The vehicle is an emergency, public service, telephone or other public utility vehicle rendering service or repairs within the immediate area where parked; or
- d. The vehicle is owned or operated by a contractor, service or delivery company bearing the name and address of commercial business and such vehicle is rendering service or making a delivery to a residence within the immediate area where parked.
- e. The Chief of Police may, in his discretion, approve permits for nonresidents upon a showing of special need.

Application for permits under subsection 7-4.16 shall be made, in writing, to the Clerk of the Borough of Flemington on forms to be provided by such Clerk. The Clerk shall issue permits if he is reasonably satisfied that the applicant is entitled thereto.

SECTION II.

Section 7A-3 is hereby amended as follows (struck through portions are to be removed; bolded and underlined portions are to be added):

In accordance with the provisions of § 7-4.5, no person shall park a vehicle for longer than the time limit shown on any of the following streets or parts of streets.

SECTION VI. If any part of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of the ordinance.

SECTION VII. Should any section, paragraph, sentence, or clause of this ordinance be declared unconstitutional or invalid for any reasons, the remaining portions of this ordinance shall not be affected thereby and shall remain in full force and effect and, to this end, the provisions of this ordinance are hereby declared severable.

SECTION VIII. This ordinance shall take effect upon adoption and publication in the manner prescribed by New Jersey general law.
