#### I. Mayor's Report

Mayor Driver noted the new audio system in Borough Hall, and said the borough's redevelopment attorney has replied to a September letter from the attorney for the Friends of Historic Flemington LLC. The response is on the hotel page of the borough website.

She outlined her activities, including a 1/14 meeting with JCP&L officials regarding traffic control during electrical line work, Gov. Murphy's legislation about permitting alcohol sales in small theaters, meeting with representatives for the developer of the Nilkanth Agway property - a March 25 presentation will be held at the historic courthouse at 7 p.m.

The Reaville Ave. sewer replacement project was done in one week. Two offers have been received for the property at 144 Main St.

#### II. Council Members' Reports

Council President Giles-McCormick

Samuel Fleming House - a proclamation is on the agenda for tonight's meeting, honoring the group's volunteers.

FCP - Lots of meetings are happening - they're working on 2- and 3-year plans for economic development, retaining businesses, and beautification.

Opportunity Zone Committee - There should be a resolution coming in a month or so about getting the grant started to hold charettes regarding the borough's future.

DPW - Progress is being made on street repairs. Their response time to issues is wonderful.

#### Council Member Hand

She mentioned her work on the Census committee, spoke of events planned over the weekend, and said she's looking forward to working in the community.

#### Council Member Harris

Park Ave. residents complained to him about the DPW's staging area for the work on Reaville Ave.

Animal Control - Licenses are due now. He's looking into having three-year licenses that match up with rabies vaccinations.

DIY - they have a terrific jazz series planned.

Beautification - Removal of the snowflakes was due to start today.

#### Council Member Long

Planning Board - there's a lot on the agenda this year, including a master plan update, and community charettes.

Census - This involves a lot of organizing; issues include communication and trust in the immigrant community.

He thanked the DPW director for giving him a tour of the town, its wells and facilities, and the Police Chief for showing him that department's operations.

#### Council Member Runion

The Environmental Commission meets Wednesday. They're continuing efforts toward Sustainable Jersey certification this year; we're 60 points shy of bronzelevel status.

He asked about progress on the Comcast franchise renewal. Mayor Driver said due to a recent court ruling, Comcast had to make some changes in its proposed contract; she expects to receive it soon.

#### Council Vice President Tilly

She outlined recent activities, including a meeting with the DPW on 1/8 regarding the Reaville Ave. sewer work, which has been completed; a 1/9 DPW-led tour of the borough; a meeting of the HPC on 1/8, where new member Adrienne Fusaro was welcomed. Property maintenance issues have prompted the inclusion of Resolution 44 on tonight's agenda, accepting the current official's resignation. The Borough is accepting resumes for the position through Wednesday, Jan. 29.

Library-There's a new book drop, and the Little Library has been relocated to Tuccamirgan Park. A pre-bid meeting is set for tomorrow at the library regarding interior renovations.

Fire Dept. - In October, with the Red Cross, they handed out 57 smoke alarms. Redevelopment - there have been very many meetings and calls so far this year.

#### III. Public Comments - Session I (up to 3 minutes each, for a maximum of 30 minutes)

Tony Previte, 45 N. Main St., said the north end of the Borough has been a dumping ground. He asked how many lawsuits are continuing against the Borough, and their status. Mayor Driver said there are 4 suits that are moving through the court system. Mr. Harris urged proactive action.

Joey Novick, 11 E. Main St., asked for a period of silence in honor of International Holocaust Remembrance Day today. Ms. Giles-Mccormick moved and Ms. Tilly seconded a motion to add a period of silence after the conclusion of voting on the meeting minutes from the reorganization. Mayor Driver suggested it be 75 seconds long, in honor of the 75th anniversary of the freeing of Aushwitz. All voted in favor.

Tony Critelli, who gave his address as Flemington, commented on borough officials' attendance at school board meetings, the charge for busing to the high school when borough children aren't bused, alternatives to Comcast, and his support for a shared services study.

Robert Shore, 47 Broad St., offered his help in negotiating a contract with Comcast to meet the needs of seniors and indigent residents, and said the shared services study should be taken seriously.

Steve Tuccio, 61 Elwood Ave., commented on the public agenda and said residents should know what's going on behind the scenes before decisions are cast in stone. He asked about enforcement of property maintenance issues at the Union Hotel, the trash/recycling situation, and the status of the escrow account in connection with the Courthouse Square project.

VIII. Public Comments - Session II (up to 3 minutes each, for a maximum of 30 minutes)

Joey Novick, 11 E. Main St., supported the extension of window hours at Borough Hall.

Rich Cornelison, 134 Main St., suggested 144 Main St. be turned into a security post with parking for a few cars, and restroom facilities for public use.

Tony Previte, 45 N. Main St., asked for action on creating a plan for the police station, and pursuing a study of shared services.

Robert Shore, 47 Broad St., supported the change in the clerk's hours, and discussed maintenance of the fence between his property and the 144 Main St. borough-owned property. He also asked for an update on the water tower project, and suggested eliminating council discussion from meetings and giving residents more time to comment. He suggested having the mayor serve as the property maintenance official. Mayor Driver said the water tower project got final site plan approval from Raritan Township's planning board in December. Steve Tuccio, 61 Elwood Ave., asked for an update on property maintenance at the Union Hotel, and the status of the escrow account. Mayor Driver said officials have been taking with the redeveloper about the escrow account; originally, bills weren't submitted correctly. Regarding the unsafe structure notice at the Union Hotel, we've been working with the owner to make sure it's secure and safe, and going on from there.

Robin Lapidus, exec. dir. of the FCP, said she was recently at a Brownfields conference, and old gas stations on the main street are very common. It's exciting that it could be something useful again. She commented on the multifamily, multi-use overlay, encouraging consideration of micro-units as well. Robert Shore, 47 Broad St., spoke about designating the whole borough an area in need of rehabilitation, which would leverage grant money and relax some laws. He suggested creating incentives for people to turn multi-family homes back into single-family homes.

Tony Previte, 45 N. Main St., suggested having a creative message board in front of the Union Hotel.

Joey Novick, 11 E. Main St., spoke in opposition to Mr. Shore's suggestion about incentives to turn multi-family homes into single-family homes.

### IX. Attorney's Report

Ms. St. Angelo said going forward, she intends to provide an attorney's report to council in advance of the meetings, which will include a to-do list. She noted that a seminar for council members is planned Sunday, Feb. 9, to go over OPMA, OPRA and ethics issues. It will be an executive session, so that council members can ask her questions.

A special civil lawsuit has been filed in connection with the police investigation of an incident; It's been referred to counsel for the borough's insurance company, and she expects it will be handled quickly.

#### X. Payment of the Bills
