Call to Order (6:00 PM)

Mayor Driver called the meeting to order at 6:00 p.m.

Ms. Hand arrived at 6:20 p.m. Redevelopment Attorney Maraziti joined the meeting by phone, briefly, from 6:30 p.m. to 6:40 p.m. Minutes of executive session kept separately.

Results of Executive Session (if any)

No action was taken. Ms. Tilly moved and Ms. Giles-McCormick seconded adjourning at 6:40 p.m., until the start of the work session at 7 p.m. All members present voted in favor.

Work Session (7:00 PM)

Mr. Harris arrived for the start of the work session.

Overview of plans for the Flemington-Raritan Community Pool - Andy Cedarbaum, Ch. Of the Bd. of Trustees of the HC YMCA, and Bruce Black, Pres. and CEO of the Y, discussed the history of the Flemington-Raritan Community Pool and how historically it was run by a group of volunteers. It suffered wear and tear and was last operational in 2017. The pool board approached the Y about taking it over. The pool has to go to a nonprofit group. Dr. Cedarbaum said the Y recently closed on ownership of the pool property, which comprises 6 acres. Mr. Black outlined the Y's plans to repair piping leaks, upgrade the bathhouse, upgrade the pool system, make things ADA-compliant, and create a fund for financial assistance. So far they've raised \$315,000 of the \$750,000 cost of renovations, and they're intending to open this summer. Memberships will cost \$595/family without discounts; former pool members and Y members will

see some discounts. There will be a sliding scale based on need. The pool will be open to County residents.

Tax Assessor presentation - Ed Kerwin

Mr. Kerwin presented data on the Borough's annual reassessment, sharing a chart with council and residents. Residential assessments are up 1.70% over 2019, and total commercial assessments are up 0.3%, led by the 4C group (multifamily apartments). Total ratables are up 0.96% over last year. He reviewed the top 10 taxpayers by assessment, noting that 5 of them are apartment complexes. Responding to a question, he said there was no significant change in the amount of properties in the Borough that don't pay taxes.

Responding to another question, he said renovations are accounted for when the construction gets a certificate of approval.

Six properties currently are on 5-year tax abatement plans; 4 of those plans expire in 2021.

II. Mayor's Report

Mayor Driver discussed the recent appellate court ruling upholding the DEP permit for sale of 90-100 Main St. She noted that a plan for development of the Nilkanth Agway property will be presented at the courthouse on March 25. The spike in suicides among young people is being addressed by Safe Harbor. The DEP is reviewing 2 offers for 144 Main St., both basically restaurants. There has been some movement on Liberty Village - she got a call from a representative of the owners, which she'll discuss later.

At the end of the Council Members' reports, Mayor Driver discussed the work session presentation about the Flemington-Raritan pool, and thanked Jeff Cain, a member of the pool board, for his hard work in arranging the transition, and also congratulated him on his position as a new Flemington-Raritan School Board member.

III. Council Members' Reports

Council President Giles-McCormick

Caitlin Giles-McCormick: She discussed some upcoming events at Samuel Fleming House and through the FCP. There's a resolution on the consent agenda regarding the Opportunity Zone Challenge Grant, so we can start organizing charettes on the future of Flemington.

Council Member Hand

Jess Hand: She and Mr. Long attended a budget seminar hosted by the NJ League of Municipalities, which was very helpful. This week she's going to an American Pets Alive conference.

Council Member Harris

Michael Harris: The Shade Tree Commission met Wednesday; they're reviewing membership and an update will be forthcoming. He's meeting with the DIY and Star Throwers groups tomorrow.

Council Member Long

Jeremy Long: The Planning Board meets next on March 2; the meeting tomorrow was canceled due to a lack of agenda items. The budgeting seminar he attended through the League of Municipalities made him feel more confident about the process. He has coffee every Saturday, 9-10 a.m., at the Flemington Coffeeshop and welcomes chats with residents.

Council Member Runion

Chris Runion: The Environmental Commission meets March 16 at 7 p.m. He's having a meeting this week with various officials regarding the possibility of getting LED lighting in the Borough. He has comments to share about Ord. 2020-1, which is set for a public hearing tonight.

Council Vice President Tilly

Kim Tilly: The DPW meetings are held the second Wednesday of every month. Bids are under review for the Library interior renovations project. The HPC has reviewed a handicapped ramp project for Catholic Charities.

IV. Public Comments - Session I (up to 3 minutes each, for a maximum of 30 minutes)

Zack Rustay, 1 Meadowbrook Road, a member of the Star Throwers Group, discussed the opportunity the group has had to meet in the Borough in a safe place for young adults to practice adulting, obtain pre-vocational training, and connect with residents and businesses in town. It offers them freedom to go where they want, and he looks forward to enjoying more time in the Borough. Jeff Cain, 54 Broad St., spoke about efforts to open the community pool.

Lois Stewart, Flemington, said trees near the former Friday's have been topped terribly, and others were removed from the parking lot. She expressed disappointment in the results of the Main Street Streetscape project.

Joanne Braun, 77 Jefferson Court, Raritan Twp., asked if Cut Glass's extension is up on its approvals. The Mayor confirmed that this is the last year of the extension.

Robert Shore, 47 Broad St., said it's important to maintain the railroad easement that runs over Route 206 to the back of Somerville, if Flemington wants trains to run to NYC again. He also asked about the shared services study, and whether the Mayor had sent a request to the state DCA. The Mayor said the request has not yet been sent because she hasn't received the address from Councilman Harris.

Robin Lapidus, exec. dir. of the Flemington Community Partnership, noted the FCP's shareholders' event at Chimney Rock is at capacity, but reservations were free.

 ORDINANCE 2020-1: SECOND READING: ELIMINATING THE OPTION OF APPEALING THE GRANT OF A "D" VARIANCE TO THE GOVERNING BODY AND AMENDING CHAPTER 14 ENTITLED "PLANNING BOARD AND HISTORIC PRESERVATION COMMISSION" OF THE GENERAL ORDINANCES OF THE BOROUGH OF FLEMINGTON, COUNTY OF HUNTERDON, STATE OF NEW JERSEY

Open public hearing - moved by Tilly, seconded by Harris, all voted yes to open. Lois Stewart, Flemington, spoke against the proposed ordinance, saying the existing ordinance gives the public the chance to voice concerns without having to hire a lawyer.

Ms. Giles-McCormick said she doesn't see a developer not appealing any reversal of planning board approval, and the current option would just prolong the process. She said people should get more involved earlier in the process, and attend Planning Board hearings.

Mayor Driver said the current ordinance could risk more expense to the Borough, if it got sued by a developer.

Mr. Runion took issue with the proposed ordinance, saying that Municipal Land Use Law says ordinances can authorize appeals to the governing body because an approval of a variance is contrary to the master plan, and while courts decide legality, locals decided what's best for the community.

Lois Stewart said the council is elected to do what's best for the community, and she hasn't seen that on the Planning Board.

Ms. Giles-McCormick said part of Council's job is to balance demands and make hard decisions.

Mr. Runion said use variances require certain conditions, and many are very subjective, such as benefit to the public and no harm being involved.

Mr. Harris reviewed the situation of the electronic sign at the circle saving it.

Mr. Harris reviewed the situation of the electronic sign at the circle, saying it illustrates the need for an appeal option.

Robin Lapidus, FCP, said communities prosper most when people have discussions and figure things out before plans go before the Planning Board. Ms. Giles-McCormick said she's struggling with how the appeal process doesn't make things more difficult.

Mayor Driver said there was plenty of opportunity for Council members to raise issues about the electronic sign at the circle early on in the process.

Mr. Long said he's liaison to the Planning Board, and he's found that they're a pretty well-rounded crew of experts and know what they're doing.

Mr. Harris said he's hearing that council doesn't even want to have the tool. Rich Cornelison, 134 Main St., expressed support for the business community. Robin Lapidus, FCP, said inclusivity has to be built in to the front part of the system. We need to invest in the belief we can be a functioning community where people get together and represent their interests, and spend more time in fruitful conversations.

Ms. Tilly moved to close the public hearing, seconded by Mr. Harris. All members voted yes.
