I. OEM Report

OEM Coordinator McNally reported there have been no new COVID-19 cases in the Borough in more than 6 weeks. The statewide transmission rate has again fallen below 1%, to 0.98%. The Governor has indicated that for the foreseeable future, there will be no indoor dining, due to problems with indoor air circulation. Storm Isaias left minimal damage in Flemington. The DPW and Police dealt well with road closures and cleanup.

II. Mayor's Report

Mayor Driver said she'd be following up with JCP&L to verify their mapping in the Borough, since their reports show outages in Flemington, but Borough officials have not found any. She noted that during Isaias, the OEM reached out to people with special needs to ensure their safety.

Hotel - Mr. Cust has people in and out of the hotel trying to determine the best way to shore it up - internally or externally. Digging is part of the archaeological study being conducted.

Reopening - The committee is planning for the start of school, and how that will affect employees and staffing. We may have to reinstate partial work-from-

home arrangements. There may be times when a staffer is alone in the office. She discussed procedures for visitors who refuse to wear a mask.

At the request of the CFO, bill lists will be done once a month, as the Borough used to do, to make cash flow more predictable.

III. Council Members' Reports

Counci Member Hand

She and Mr. Long had their first meeting of the Citizens Working Group and it went well - she believes their work will have a positive impact on the town. Community Garden - She urged people to reach out to her to join the committee organizing this.

Council Vice President Tilly

Reopening - There have been a few committee meetings.

Redevelopment - This committee is still meeting.

Fire - They're holding a 50/50 raffle. In July there were 16 incidents, requiring 67 hours and 21 minutes of service. Members also spent 54 hours in training. Library - The painting is done and the railing installed. The vestibule needs windows and doors. The summer reading program, held entirely online, was very successful.

Property Maintenance - there have been 2 complaints. She urged people to be good neighbors and keep their lawns mowed.

A fall townwide yard sale is being planned. A resolution should be on the agenda for the next meeting.

Council Member Runion

Electric Vehicle charging station - We're having the second reading tonight on an ordinance to accept an easement for sidewalks in the area where a charging station is planned.

Environmental Commission - For Sustainable Jersey certification, they need to update the natural resources inventory, which is used to inform the master plan. Mayor Driver noted that conversations are continuing about how to do the master plan review to allow for public participation.

Council Member Harris

Shade Tree Commission - An ordinance is on the agenda to re-establish the commission, and a resolution appoints members for this year.

Schools - They're planning for the coming school year in light of COVID-19.

Animal Control - The ACO is working on getting out notices about license renewals and rabies vaccinations.

Council Member Long

Citzens Working Group - They're putting together questions for Police Chief Rotella, and will have him come to a meeting in the future to address them.

Planning Board - By-laws and rules for participation were adopted. They've suggested a subcommittee be organized to look at their website, in light of the creation of a new Borough website.

Global Ag - They reviewed the proposed amendment to the redevelopment plan, and he will make a motion to amend the ordinance on tonight's agenda to accommodate the Planning Board's suggestions.

Administration - He's been talking to officials in area communities getting tips and strategies on how to hire a borough administrator. He said he thinks having a borough administrator will help make this community stronger and healthier for everyone, as we continue to recover from the COVID-19 pandemic.

Council President Giles-McCormick

She thanked Mr. Long for his exploratory work regarding a borough administrator, saying it's vital so we can work more efficiently.

Samuel Fleming House - A tree fell causing some minor damage to the gazebo and fencing; luckily it fell between the two houses that are close together.

Mayor Driver thanked the DPW for its quick work removing the tree. She listed some scheduled events.

FCP - They're doing business spotlights on Facebook and their website, boosting local businesses. They're working on parking communications and signage. They're running a promotion on Saturdays, noon-4 p.m., "chill out" in Flemington. The Filling Station will reopen soon at a new location in Turntable Junction. Redevelopment - The committee has been meeting individually and with the redeveloper; the meetings have been productive.
