1. Mayor's Report

Mayor Driver received a lovely letter and package in the mail from Linda Kendrick, filled with older photos and postcards of Flemington. Linda's great grandfather, Carrie Dietz was once a prominent citizen in Flemington, and left a stack of photos and documents. The Mayor will send a thank you note and will make sure that these items are archived.

The Mayor then deliver a proclamation to Edward Mahn, a pillar to the Flemington Community for more than 50 years of service as a businessman and volunteer.

2. Council Members' Reports

Council Vice President Hand

Council Vice President Hand announced that the community garden fence is delayed due to some financial issues. Ms. Hand attended the Corn, Tomato and Beer Festival and gave kudos to FCP and all the volunteers.

Council Member Johnston

Council Member Johnston gave a shout out to Debbie Moore, the Children's Librarian, who recently completed the summit children's reading program. At the end of the month, a new art gallery goes up on the walls of our library. This month Joy Sanchez artwork is being displayed, so take a minute and please stop. New flowers were planted by the DPW and Scout Troop #62.

Council President Long

Council President Long presented police news. Unfortunately, we've had a slight uptick in overdoses recently. There was a cell phone stolen from an individual at the Chic-fil-A.

For Flemington Community Partnership news, the fifth annual Corn, Tomato and Beer Festival was a resounding success, with gorgeous weather and an estimated 10,000 to 15,000 people at the event. The FCP surveyed their vendors and the majority have said that they far exceeded their expectations financially and in terms of ease of operations. The FCP spent more money on staffing for the event than in past years and had a good number of volunteers but still a large one day undertaking for such a small group, of people. They wish to thank the Mayor and Council, the Liaison, Clerks Graziano and Humphrey, the Borough Hall staff, the police, the DPW OEM, the EMTs and the fire department personnel who all helped to make this great day possible. At the next meeting we will have event fundraising reports from the Fired Department and financial reports from the FCP. The festival creates invaluable PR for the Borough and our businesses. Next up is the Central Jersey Jazz Festival at Stangl. That's on Friday, September 9, and the Hunterdon Harvest Fest on October 1st. Also, the FCP is launching the NPP residential grant by the end of the week, providing 15 \$1,000 grants to owner operated residences for facade improvements, focused on the South End this year. The work must be completed by the end of October.

Civic Engagement is postponing the volunteer event to October. The event is focused on showing residents how to get more involved in the community and potential leadership opportunities.

Council Member Parker

Council Member Parker said that the Corn, Tomato and Beer Festival was amazing, and his guests from out of state were blown away by it.

Council Member Rosetti

Council Member Rosetti shared that the Code Enforcement Officer, Dave Giulliani is out of the office for the next week, and communications will be covered by the Construction Official.

Council Member Tilly

Council Member Tilly discussed the DPW meeting. The Borough is under a voluntary water conservation alert, and not under a mandatory conservation yet. Dewey Avenue will finish once the concrete mix is approved. A crosswalk was repainted on East Main Street and New Jersey Avenue in anticipation of school starting.

The Fire Department met on the 9th. On September 7th the hoses and ladders will be tested. On the 18th Council Member Tilly met the Chief and the Deputy Chief to explore volunteer recruitment.

On the 10th we had a meeting discussing the Hopewell Avenue construction project. The 17th was an HPC meeting, where we heard two applications at 23 Maple Avenue, exterior work and paint polar change that was approved as presented. The second application was 2729 Park Avenue. That was exterior and porch work that was approved with a couple of recommendations.
