1. Mayor's Report

Mayor Driver reported that night work construction on the Elizabethtown gas main replacement project on Main Street continues, she expressed apologies to those residents affected by the noise. She was on site the first night. Unsafe driving in the work zone forced us to make a decision between two bad choices: close Main Street during the business day and cause problems for commuters, workers and businesses, or do the work at nighttime. She noted the upcoming introduction of an ordinance adding two crosswalks to Stangl Road that are much overdue. She noted designating Corcoran Street and North Place as one-way streets, necessitated so that we can rebuild Corcoran, fix the horrible shape of the road and replace infrastructure underneath.

Council Vice President Hand

Council Vice President shared good news about the Flemington Community Garden. Habitat for Humanity has funds available that can be used for a fence to be built by November. She discussed meeting for the community energy planning grant, which was awarded \$25,000 to help the Borough work towards a better environment for all residents. Council Member Johnston

Council Member Johnston reported that the Library basement remediation process is about to begin dealing with asbestos and mold. The summer reading program went well. On October 13th at 7:00 pm the library will host the bedtime stories for Halloween. The library catalog is now available online. Dominos are played every Wednesday at 7:00 pm. The Doric House Museum hosted Eva, the instructor for Tuesday yoga classes, who gave over \$300 in donations to the museum last week. On October 8th a pumpkin decorating event was held, where decorating supplies were donated by ShopRite. A Tricky Tray will be coming up soon. For the courts, the case load is up 18% from prior year. The court is still virtual except for special circumstances.

Council President Long

Council President Long shared the police department's request to drive with care and caution due to the construction in the Borough. The Police Department received and awarded from Go Hunterdon for their pedestrian safety campaign during the Summer. They also want to thank Joe Hunter for the continued support over the years. The Police Department be enforcing permit parking on days when school is in session, and on weekdays throughout the town. Residents can come to Borough Hall to get a parking

permit and/or visitor pass. Please pay attention to parking signs on your street. There have been several vehicle burglaries and auto thefts in the community, so please lock your vehicle and do not leave your keys or key fobs in the vehicle. Halloween Trick-or-Treating will take place from 4:00 PM to 8:00 PM on Monday, October 31st, taking place on Broad Street from William Street to Pennsylvania Avenue, and Bonnell Street from Park Avenue to Shields Avenue. This is done for the safety of trick-or-treaters. As always see something say something call 911 If you feel like there's an emergency and call the non-emergency number at 908-782-3434.

The FCP's Harvest Fest was postponed to the October 29th due to rain. They plan to have over 100 vendors from all over Hunterdon County. SAFE of Hunterdon will be a beneficiary of this event. The FCP is working with the businesses on Main Street to produce the Annual Kids Costume Parade contests on Thursday, October 27th between 5:00 PM and 8:00 PM, on Main Street between Mine Street and Fulper Street. On October 28th, from 6:00 PM to 10:00 PM, the FCP and the Stangl businesses are putting on a new event called the Stangl Witch Walk. It is a strolling event featuring an annual witch dance and an open cauldron. The night will be filled with music, dancing, shopping and more. FCP is purchasing new large holiday decorations for Main Street and hoping to light more trees. Fifteen businesses received improvement grants of \$1,000 each. Those improves will be starting very soon. An article about Flemington being chosen one of Jersey's five best destinations is out. This positive press is invaluable to keep customers coming to our businesses.
