I. Call to Order

1. Statement regarding OPMA

This meeting is called pursuant to the provisions of the Open Public Meetings Law. This meeting of October 24, 2022 was included in a list-of-meetings notice sent to the Hunterdon County Democrat and Courier-News on Jan. 5, 2022, posted on the bulletin board at Borough Hall on that date, and has remained continuously posted as required. In addition, a copy of this notice is and has been available to the public and is on file in the office of the Borough Clerk.

II. Work Session (7:00 PM)

Mayor Driver introduced HPC members Jennifer Williford and Wendy Orr for a presentation on the 2023 House Tour.

Ms. Williford shared how COVID has slowed down historic house tours in recent years, and what the resumption of the tours will look like in 2023. She introduced several of the other HPC members, including Dennis Schoeb, Wendy Orr, and shared her thanks to Kristen and Tood Cook for committing their home for the 2023 tour. The focus of the tours is to increase tourism, showcase the beauty of the homes, and share the warm and welcoming community with more people.

HPC is working with FCP to design the tours to increase foot traffic in the shops and restaurants in Flemington. They are using a passport-like concept to encourage a loyalty shopping program that combines our history with our commerce. The goal to produce six to eight homes and four buildings. Several homeowners and building owners have already committed. The last year of the tours in 2016 sold approximately 180 tickets, so they are anticipating about between 250 to 350 for 2023. In comparison, the Lambertville House Tours yesterday sold 800 tickets, and the HPC aim is to eventually challenge those numbers. It will be a lot of work to get this off the ground.

Ms. Williford thinks that the Borough is on this cusp the next great thing coming down the pike in Flemington and a great way to get people visiting our town and get the enthusiasm going. She said that they are pursuing a sponsor to fund trolleys as part of the tours, taking people from place to place.

The HPC would borrow from the \$10,000 generated from previous house tours of 2014 and 2016. They will be pursuing sponsorships, and recruiting and training additional volunteers to help. All with the target of rolling out the red carpet on June 3 of 2023.

1. Mayor's Report

She also attended the SAFE in Hunterdon candlelight vigil at the historic courthouse last week. The Mayor appointed Caitlin Giles McCormick to the HPC is alternate to member. Mayor Driver attended the addicted chic anniversary event over the weekend. They've been in business for 40 years. She also took a moment to wish good luck to all the candidates running.

Council President Long

Council President Long shared news about Halloween on October 31st, from 4:00 pm to 8:00 pm, with road closures possible on Broad Street from Pennsylvania Avenue to William Street and on Bonnell Street from Park Avenue to Shields Avenue. All streets will be open for vehicle and pedestrian traffic, so please proceed with caution. Mr. Long shared several safety tips. The FCP is helping to produce the annual kids costume parade on Main Street, between Mine Street and Fulper Road, on Thursday, October 27th from 5:00 pm to 8:00 PM. On Friday, October 28th, the FCP is holding a new event called Stangl, which includes an outdoor movie and open cauldron with libations from Lone Eagle Brewing and items from Blue Fish Grill, and a whole lot of surprises in between. On Saturday, October 29th, Flemington will host Harvest Fest, with over 100 vendors, eight local craft breweries and one cidery, plus crafts, great food and entertainment. SAFE of Hunterdon will is the beneficiary. Fifteen businesses are working hard to improve their look of their storefronts, and 15 homeowners are also taking FCP grants to make exterior home improvements. We will show before and after photos in December so stay tuned. The FCP is purchasing new holiday decorations for Main Street. The FCP was awarded Partner of the Year Award last week from the Hunterdon County Department of Economic Development tourism for the significant number of partnerships initiated with the county and their commitment to the economic growth of the entire county. On Monday, October 17, Council President Long took part in the Zoom question and answer session with students in Mr. Georgio's class. It was an honor to have spent some time with these students and to help them understand our local government better. Thank you to the CEA school in Georgia for inviting me into your classroom. Along with the Mayor, Mr. Long attended the candlelight vigil held by SAFE of Hunterdon, and the anniversary event of Addicted Chic.

Council Member Parker

Council Member Parker also attended that SAFE event last Thursday, which was a very special event for him. He has been collecting information from residents and business owners to create an effort to increase engagement in the Borough. He sees that not everyone feels a part of the community. He wants to build an effort about reuniting and getting people involved.
