1. RESOLUTION 2024-40 - RESOLUTION RECOGNIZING BLACK HISTORY MONTH

WHEREAS, every February, Black History Month is recognized to not only encourage the study of African American life and history but also act as a reminder that Black history is an integral part of the history of the United States of America; and

WHEREAS, what began as a week recognizing Black History, championed by Dr. Carter G. Woodson and minister Jesse E. Moorland in 1926, when they founded the Association for the Study of African American Life and History (ASALH) evolved into a month by 1976, after official recognition by then President Gerald Ford; and

WHEREAS, each year, the Association presents a new theme, and the theme for 2024 is African American and the Arts; and

WHEREAS, for African Americans, the arts have been a means to express joy and sorrow, assert humanity, or communicate in a way that reaffirms one another; and

WHEREAS, Alvin Ailey, Colman Domingo, Michaela Jaé Rodriguez, Billie Holiday, and others made it clear Black and LGBTQ+ people not only exist but could do so openly; and

WHEREAS, women like Eartha Kitt, Maya Angelou, Queen Latifah, Audra MacDonald, Viola Davis, and more not only exhibited Black women aren't a monolith but there isn't a limit, standard, or any imposed glass ceiling that could hold their talent back from the applause of the masses; and

WHEREAS, as with every Black History Month, there is also a need to remember Black History is not only American History, but the contributions of Black Americans go beyond those who provide entertainment. Michael Jackson popularized the Super Bowl halftime show as a must-see event; James E. West's patents from 1962, utilized in 90% of all microphones today, allowed over 133 million people to hear his set list, and

WHEREAS Mark Dean, while working at IBM, developed the first gigahertz chip that laid the foundation for the technology required to hear, see, and experience entertainment on a computer or phone, and Valerie Thomas, a NASA data analyst, advanced the 3D technology used in theaters across the nation and the world.

NOW THEREFORE, BE IT RESOLVED on behalf of the Flemington Borough Council, highlight these names in honor of Black History Month and ask the public to further educate themselves on those named and the many others who have shaped our country and the world.

4. RESOLUTION 2024-38 - RESOLUTION OF THE BOROUGH OF FLEMINTON COUNTY OF HUNTERDON, STATE OF NEW JERSEY, AUTHORIZING THE BOROUGH OF FLEMINGTON TO SUBMIT AN APPLICATION FOR 1.4 MILLION TO NEW JERSEY WATER BANK FOR MAIN STREET SEWER IMPROVMENTS

WHEREAS, the Borough of Flemington (hereinafter the" Borough") plans to submit to the New Jersey H₂ Loans Clen Water Program an application for financing for Main Street Sewer Improvements (hereinafter the "Program"); and

WHEREAS, the Borough wishes to pursue through the Program funding for the replacement of sewer mains, laterals, cleanouts, manholes, and other improvements for Main Street from Church to the Route 12 Circle; and

WHEREAS, it is in the best interest of the Borough to pursue this project actively and diligently, for reasons associated with the health, safety, and welfare of the community serviced by the Borough; and moreover, pursue funding with and through H₂ Loans Clean Water program for the sewer work.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Flemington County of Hunterdon, State of New Jersey, as follows:

- 1. All necessary action, including the filing of formal applications, be taken to pursue with New Jersey H₂ Loans actual funding for replacement of sewer mains and appurtenances for Main Street from Church to Route 12 Circle.
- 2. The Borough is authorized to accept all funding through the New Jersey H₂ Loans Clean Water Program.
- 3. The Borough's Municipal Clerk shall publish an appropriate notice of intention to file an application with New Jersey H₂ Loans Clean Water program for funding for the proposed projects in the Borough's official newspaper with sixty (60) days of the Borough's submission of an application for funding to H₂ Loans.
- 4. The duly authorized representatives of the Borough, including the Borough's Special Projects Engineer, Solicitor, and Auditor, be authorized to execute all documentation in furtherance of the preparation of the necessary documents to be submitted to New Jersey H2 Loans Clean Water Program Further, the Mayor of the Borough is hereby authorized to execute the necessary documents in order to provide the application to H2 Loans.
