Call to Order

Mayor Driver called the meeting to order at 7:00 p.m. Attorney Leslie Parikh attended in place of Attorney St. Angelo. All Council members were present, with Ms. Rosetti attending through Zoom. The Mayor read the following statement:

This meeting is called pursuant to the provisions of the Open Public Meetings Law. This meeting of April 25, 2022 was included in a list-of-meetings notice sent to the Hunterdon County Democrat and Courier-News on Jan. 5, 2022, posted on the bulletin board at Borough Hall on that date, and has remained continuously posted as required. In addition, a copy of this notice is and has been available to the public and is on file in the office of the Borough Clerk.

Work Session (7:00 PM)

Presentation by Prevention Resources regarding the Open Door Recovery Center and Hunterdon's Stigma-Free Task Force - Amy Hicks and Karen Widico Ms. Hicks discussed the efforts of the Hunterdon County Stigma-Free Task Force and shared some ideas of how communities can work together to ease the stigma of mental health issues. She has a toolkit available to share letters, posters, event ideas and more.

She also discussed the Open Door Recovery Center, located at 5 E. Main St., which is a peer-run community center for people struggling with substance use issues. They offer resources, counseling, sober recreational opportunities and more.

Ms. Widico said she's seen a shift toward more stigma-free communities. The session ended at 7:16 p.m. and Council adjourned until the start of the regular meeting at 7:30 p.m.

I. Mayor's Report

Mayor Driver said the Courthouse Square project is moving toward the next stage. With the final building on the site down, digging and setting footings will be next.

Road projects on Hopewell and Dewey avenues have been delayed because there's a supply-chain issue with the pipes.

The Liberty Village redevelopment committee is meeting this week and finishing up work on the Redeveloper's Agreement.

Mulch is available, but the quality isn't great this year.

II. Council Members' Reports

Council Member Johnston

Mr. Johnston reminded people that the Samuel Fleming House has an open house planned on May 7.

Council Vice President Hand

Ms. Hand discussed the work session and the Open Door Recovery Center at 5 E. Main St.

On Sunday at 2 p.m. the townwide cleanup will take place. Meet at the Borough Garage at 8 Main St. (rear).

The Environmental Commission will meet by Zoom on May 16.

Council President Long

Mr. Long reviewed March Police statistics. There were 229 motor vehicle summonses in March, compared to 176 in February. In March there were also 3,338 CAD incidents, 36 investigations, and 32 accidents. Shoplifting and thefts have been reported, and police are happy to meet with business owners to help train their staffs.

The police station, at 100 Main St., is participating in the Drug Enforcement Agency's Take Back event on April 30. From 10 a.m. to 2 p.m., people can drop off unwanted medication - except no needles, liquids or inhalers.

Regarding loud exhausts, police have made 20 stops so far. He did a ride-along with Cpl. Hribik and Patrol Officer Aquino and said it was very enlightening. FCP- Event listings have been updated. Flowers for the planters will arrive in June. Parking signs are being redone. Proposals are being accepted for art murals. He reminded residents that New Jersey's single-use plastic bag ban starts May 4. People should email Mr. Long if they'd like to participate in events to promote citizen engagement.

Council Member Tilly

Ms. Tilly has almost completed her CERT training. She welcomed Mr. Parker to Council. She said the HPC is gearing up for a house tour in 2023.

Fireworks will be held this year, on July 3 (rain date July 5) at RFIS.

This weekend is the townwide yard sale.

The Open Door Recovery Center is in the Family Harvest building on East Main Street. She encouraged people to visit their open house.

Council Member Parker

Mr. Parker is awaiting his council assignments and had no report for this meeting.

Council Member Rosetti

Ms. Rosetti discussed the community cleanup planned Sunday, May 1, starting at 2 p.m.

Thank you for the opportunity to present this proposal for professional services related to a fiscal review of a proposed redevelopment project. It is our understanding that the scope of the project is approximately 375 residential units with an affordable housing set aside, as well as a modest commercial component. The core issue, as we understand it, is a review of the project pro forma for the identification of reasonable assumptions and allocations and assistance with the negotiation of a redevelopment agreement and a financial agreement.

Beacon Planning has extensive experience in guiding communities through the redevelopment process, particularly in evaluating financial considerations. The depth our in-house resources, which include real estate professionals, an economist and an appraiser, have been a key component in the satisfaction expressed by our clients.

The reimbursable expenses will be added to each monthly invoice.

### Calendar Year 2022 Ordinance to Exceed the Municipal Budget Cost of Living Allowance and to Establish a Cap Bank When the COLA is Equal to or Less Than 2.5 Percent (N.J.S.A. 40A:4-45.14)

Flemington Borough, Hunterdon County

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% or the Cost-of-Living Adjustment (COLA), whichever is less, over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.14 provides that a municipality may, in any year in which the COLA is equal to or less than 2.5%, increase its final appropriations by a percentage greater than the COLA, but not to exceed the 3.5% rate as specified in the law, when authorized by ordinance; and,

WHEREAS, the COLA for 2022 has been certified by the Director of the Division of Local Government Services in the Department of Community Affairs as 2.5% and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, in any year in which the COLA is equal to or less than 2.5%, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Flemington in the County of Hunterdon finds it advisable and necessary to increase its 2022 budget by more than 2.50% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$49,987.41 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Flemington, in the County of Hunterdon, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the 2022 budget year, the final appropriations of the Borough of Flemington shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% amounting to \$174,955.94 and that the 2022 municipal budget for the Borough of Flemington be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

### ORDINANCE 2022-6

DOC ID: 3772

### Amending Section 7-4.2 of the Code of the Borough of Flemington Regarding Parking During Snow Emergencies

WHEREAS, the Code of the Borough of Flemington prohibits parking on streets and certain parking lots during snowstorms; and

WHEREAS, the Borough Council wishes to clarify that the prohibitions are only in effect when the Borough of Flemington has declared a "snow emergency;" and

**NOW, THEREFORE, BE IT ORDAINED**, by the Borough Council of the Borough of Flemington, in the County of Hunterdon and State of New Jersey, as follows:

<u>Section 1.</u> Section 7-4.2 of the Code of the Borough of Flemington, entitled "Parking Prohibited During State of Emergency," shall be amended as follows:

a. Parking During a Snow Emergency. Streets and highways.

1. Whenever snow has fallen and the Borough of Flemington declares a snow emergency and the accumulation is such that it covers the street or highway, an emergency shall exist and no vehicle shall be parked on any street or highway in the Borough of Flemington. The above parking prohibition shall remain in effect after the snow has ceased until the declaration of a snow emergency is lifted streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.

2. Municipal parking lots. Whenever snow has fallen and *the Borough of Flemington declares a snow emergency* the accumulation is such that it covers any municipal parking lot, an emergency shall exist and no vehicle shall be parked in any municipal parking lot in the Borough of Flemington. *The above parking prohibition shall remain in effect after the snow has ceased until the declaration of a snow emergency is lifted* 

3. Exceptions: Residential - Snow emergency parking.

(a) Any vehicle that is parked in a designated "Residential - Snow Emergency Parking" area located within a municipal parking lot.

(1) Areas #1, #2, #3, #4 and #5;

(2) Parking lot located to the rear of the Flemington Borough Hall and Fire House, 38 Park Avenue.

4. Declaration of a Snow Emergency.

(a) When in the opinion of the Chief of Police, in consultation with the Mayor, Office of Emergency Management Coordinator, and Department of Public Works Supervisor, the actual or expected precipitation of snow will create hazardous or dangerous street and highway conditions for vehicular or pedestrian traffic, he/she may in the manner set forth herein, declare that a snow emergency exists in the Borough or in a section or sections thereof.

(b) The Chief of Police shall immediately inform the public of the snow emergency by issuing a statement in a manner determined in consultation with the Mayor, Office of Emergency Management Coordinator, and Department of Public Works Supervisor.

(c) The Chief of Police may declare any snow emergency route or any part of a snow emergency route to be free from the restrictions herein imposed, or the snow emergency terminated, when in his/her opinion the weather or street conditions warrant such a determination. The Chief of Police shall give notice of this determination in the manner provided for in paragraph b of this section.

Parking During a Declared Local or State Emergency Due to Snow or b. Hazardous Weather Conditions.

Whenever a state of emergency has been declared in compliance 1. with the N.J.S.A. App. A:9-1 et seq. as a result of snow or other hazardous weather conditions, no vehicle shall be parked on any street, highway, or municipal parking lot in the Borough of Flemington.

#### 2. Exceptions: Residential - Snow or other weather emergency parking.

Any vehicle that is parked in a designated "Residential - Snow (a) Emergency Parking" area located within a municipal parking lot. (1)

Areas #1, #2, #3, #4 and #5;

(2) Parking lot located to the rear of the Flemington Borough Hall and Fire House, 38 Park Avenue.

Parking During Other Declared Emergencies, Traffic Conditions, or Public C. Events Where Signage is Posted.

Upon the declaration of an emergency or other traffic condition by the Chief of Police, in consultation with the Mayor, Office of Emergency Management Coordinator, and Department of Public Works Supervisor, there shall be no parking upon streets or sections of streets where temporary "EMERGENCY-NO PARKING" signs are displayed.

The Chief of Police (or his/her designee), in consultation with the 2. Mayor, Office of Emergency Management Coordinator, and Department of Public Works Supervisor chief of pelice, or in his absence, the ranking police officer, is authorized to declare an emergency and to direct the posting of said "EMERGENCY, NO-PARKING" signs when weather conditions, accidents, fires, or public celebrations dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic.

Notification that the "EMERGENCY, NO-PARKING" signs are being or will be posted shall be given to the operator or owner of any vehicle which has been parked prior to the posting of the sign.

Any unoccupied vehicle parked or standing in violation of this subsection shall be ed. deemed a nuisance and a menace to the safe and proper regulation of traffic and any police officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of removal and storage which may result from such removal, before regaining possession of the vehicle.

The provisions of paragraphs a, b and c shall not apply to any fire-fighting de. equipment, ambulance or other emergency equipment actively engaged in dealing with an emergency in the Borough.

#### ef. Violations and Penalties.

1. Unless another penalty is expressly provided by New Jersey Statute, every person convicted of a violation or provision of this subsection or supplement thereto, shall be liable to a penalty of not more than \$500.00 or imprisonment for a term not exceeding 90 days or both.

In addition to any other fine or penalty that may be imposed, any 2. unoccupied vehicle parked or standing in violation of subsections (b) or (c)

hereof (i.e. during the declaration of a local or state emergency or other traffic condition) this article shall be deemed a nuisance and a menace to the safe and proper regulation of traffic, and any police or peace officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage which may result from such removal before regaining possession of the vehicle. This provision shall not apply if only a "Snow Emergency" pursuant to subsection (a) has been declared.

<u>Section 2.</u> The Chief of Police, in consultation with the Mayor, Office of Emergency Management Coordinator, and Department of Public Works Supervisor, is hereby authorized to direct the posting of signage consistent with this ordinance.

<u>Section 3.</u> All ordinances of the Borough of Flemington, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

<u>Section 4.</u> If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

<u>Section 5.</u> This Ordinance shall take effect upon final passage and publication as required by law.
