RESOLUTION 2023-144: AUTHORIZING THE AWARD OF FOR ARCHITECTURAL SERVICES TO PAULUS SOKOLOWSKI & SARTOR FOR DESIGN WORK FOR THE FLEMINGTON BOROUGH POLICE STATION IMPROVEMENT PROJECT

WHEREAS, the Borough of Flemington has a need to procure architectural services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5 for design work related to the Borough Police Station Improvement Project; and,

WHEREAS, the scope of services for the contract to be awarded by this resolution are as follows:

- 1. Phase 1: Design of handicapped public restroom on first floor (including preparation of bid documents);
- 2. Phase 2A: Design of the facility's Processing Center, including holding room(s), restroom(s), office(s), and mechanicals as needed for the ground floor (including preparation of bid documents);
- 3. Phase 2B: Design of ground floor of facility (exclusive of 2A), including breakroom, locker room, kitchen, and restrooms (including preparation of bid documents); and
- 4. Outfitting of new generator.

WHEREAS, the chief financial officer has determined and certified in writing that the value of the acquisition will exceed \$17,500; and,

WHEREAS, the anticipated term of this contract is one (1) year; and

WHEREAS, Paulus, Sokolowski & Sartor has submitted a proposal June 30, 2023 indicating they will provide the aforementioned services for the in accordance with the attached fee schedule in an amount not to exceed \$XX,XXX; and

WHEREAS, Paulus, Sokolowski & Sartor has completed and submitted a Business Entity Disclosure Certification which certifies that Paulus, Sokolowski & Sartor has not made any reportable contributions to a political or candidate committee in the Borough of Flemington in the previous one year, and that the contract will prohibit the Paulus, Sokolowski & Sartor from making any reportable contributions through the term of the contract, and

WHEREAS, this Contract may be and shall be awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. 40A: 11-5(1)(a) of the Local Public Contracts Law because these services are rendered or performed by a person authorized by law to practice a recognized profession; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A: 11-1 et seq.) requires that the resolution authorizing the award of contract for "Professional Services," without competitive bids and the contract itself, must be available for public inspection; and

WHEREAS, the availability of funds has been certified by William Hance, Chief Finance Officer, who shall make an appropriate entry into the Borough's encumbrance system, in the amount of \$XX,XXX, from account number 3-01-630-216 pursuant to N.J.A.C. 5:30-5.1 and 5.2, and said certification being attached to the resolution; and

NOW THEREFORE, BE IT RESOLVED that the Borough of the Flemington authorizes the Mayor to enter into a contract with Paulus, Sokolowski & Sartor as described herein in an amount not to exceed \$XX,XXX; and,

The Municipal Court Administrator appointed on an Interim basis may be reappointed for a fourth, and, if necessary, a fifth additional one-year term, provided the Municipal Court Administrator is currently enrolled in the certification program and need additional time to complete that program".

RETURN FROM EXECUTIVE SESSION:

RESOLUTION 2023-145: APPROVING THE AWARD OF A CLASS 5 CANNABIS LICENSE TO BLESS WELLNESS

WHEREAS, pursuant to N.J.S.A. 24:6I-31 et seq., the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act ("the Act") authorizes the legal use of recreational cannabis by adults aged twenty-one (21) and older; and

WHEREAS, the Act further establishes a comprehensive regulatory licensing scheme for commercial recreational (adult use) cannabis operations, use, and possession; and

WHEREAS, the Act establishes six (6) marketplace classes of licensed cannabis business, specifically including retail sales as a Class 5 license; and

WHEREAS, Ord. No. 2023-02 as approved on March 13, 2023 by the Borough Council of the Borough of Flemington authorizes two (2) Class 5 retail licenses; and

WHEREAS, pursuant to N.J.A.C. 17:30-5.1(a)(4), a local municipality may impose a separate local license requirement, which the Borough of Flemington has done pursuant to Chapter 95 of the municipal ordinances thereof; and

WHEREAS, the Borough has undertaken the licensing process pursuant to Section 95-7 of the municipal ordinances thereof and has reviewed four (4) applications for a Class 5 retail license;
