<u>PRESENTATION:</u> Presentation from Stephen Sullivan of Wilentz Attorneys at Law discussing joining a Class Action Lawsuit regarding "Forever Chemicals"

Mr. Sullivan explained that he and his partner, John Keefe have been involved in successful litigation cases against PFAS manufacturers, regarding their knowledge of and responsibility for New Jersey's and the other PFAS manufacturers and represent water providers who face the burden of PFAS contamination and the requisite costly upgrades to their treatment facilities. Mr. Sullivan explained how he and Mr. Keefe will evaluate the Borough's water testing and other data to determine whether litigation in the MDL (Muti-District Litigation) is appropriate for the Borough.

Council and Mr. Sullivan discussed the contingency basis, which is Wilentz will not recover its investigation or litigation costs or attorney's fees unless the Borough receives a favorable settlement, judgment and/or other resolution.

Mayor Karrow amended the agenda to add Executive Session regarding potential litigation regarding the PFAS "Forever Chemicals." Action will be taken after the Executive Session.

WHEREAS, pursuant to State Statutes a municipality can abate safety hazards on private property and authorize the tax collector to place a lien on the property to recover the costs.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Flemington, County of Hunterdon, State of New Jersey that a contract be awarded to R & S Landscaping in the amount of \$2,050.00 to abate the current hazards on block 46 lot 7, known as 217 S. Main Street.

4. ORDINANCE 2021-21 - AN ORDINANCE AMENDING CHAPTER 9A-3 "CONSTRUCTION PERMIT FEES" TO MODIFY VARIOUS FEE AMOUNTS

John Tillotson, the Construction Officer explained the Ordinance.

WHEREAS, the Borough of Flemington desires to amend Chapter 9A-3 to update and amend its fees for various building construction items.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Flemington in the County of Hunterdon, State of New Jersey that:

Section 1. Chapter 9A-3(a) and (b) shall be amended as follows (deletions are noted thusly; additions are noted thusly:

- 1. General.
- 2. The fee for plan review, computed as a percentage of the fee for a construction permit, may be paid at the time of application for a permit. The amount of this fee, if prepaid, shall then be deducted from the amount of the fee due for a construction permit, when the permit is issued. Plan review fees are not refundable.
- 3. The fee to be charged for a construction permit will be the sum of the basic construction fee plus all applicable special fees, such as elevator or sign fees. This fee shall be paid before a permit is issued.
- 4. The fee to be charged for a certificate of occupancy shall be paid before a certificate is issued. This fee shall be in addition to the construction permit fee.
- 5. The minimum fee for all subcode fees shall be \$75.00.
- 6. Flemington Building Department fees shall be as follows:
- 7. Plan review fee: The fee for plan review shall be 20 percent of the amount to be charged for a new construction permit \$100.00 per hour (with an established minimum of one-half

hour), except that elevator device plan review shall be as set forth in N.J.A.C. 5:23-4.20(c) 6 and 7. The plan review fee for updates and as-builts shall be \$100.00 per hour (with an established minimum of one-half hour).

- 8. The basic construction fee shall be the sum of the parts computed on the basis of the volume or cost of construction, the number of plumbing fixtures and pieces of equipment, the number of electrical fixtures and devices and the number of sprinklers, standpipes and detectors (smoke and heat) at the unit rates provided herein plus any special fees
- (a) Building volume or cost: The fees for new construction or alteration are as follows:
- (1) For new construction in Residential Use Groups U, R-3, R-4, and R-5, \$0.038 \$0.045 per cubic foot of building or structure volume, provided that the minimum fee shall be \$200.00.

For new construction in Commercial Use Groups A, B, E, F, H, I, M, S and U, \$0.040 per cubic foot of building or structure volume up to 100,000 cubic feet and \$0.020 per cubic foot over 100,000 cubic feet provided the minimum fee shall be \$200.00.

(2) For renovations, alterations and repairs in Residential Use Groups U, R-3, R-4 and R-5, \$15.00 \$30.00 per each \$1,000.00 of actual construction cost provided the minimum fee shall be \$60.00.

For renovations, alterations and repairs in Commercial Use Groups A, B, E, F, H, I, M, S and U, \$20.00 \$30.00 per each \$1,000.00 of actual construction cost provided the minimum fee shall be \$100.00.

(3) For additions in Residential Use Groups U, R-3, R-4 and R-5, \$0.038 \$0.045 per cubic foot of building or structure volume provided that the minimum fee for Residential Use Groups R-3 and R-4 shall be \$50.00 and the minimum fee for Residential Use Groups U involving less than 1,000 cubic feet of building or structure volume, \$60.00.

For additions in Commercial Use Groups A, B, E, F, H, I, M, S and U, \$0.040 per cubic foot of building or structure volume up to 100,000 cubic feet and \$0.015 per cubic foot over 100,000 cubic feet provided the minimum fee shall be \$200.00.

- (4) Fees for combination renovations and additions shall be computed at the sum of the fees computed separately in accordance with (2) and (3) above.
- (5) Fees for the construction of in ground swimming pools shall be \$100.00 \$350.00 and \$50.00 \$100.00 for above ground pools; these fees are in addition to any required electrical and plumbing subcode fees.

Fees for pool barriers and fencing over 6 foot shall be \$100.00.

- (6) Fees for the construction of decks in Residential Use Groups R-3, R-4 and R-5 shall be \$10.00 per each \$1,000.00 of actual construction cost provided the minimum fee shall be \$75.00; the fees for decks shall include the three required inspections.
- (7) Re-roofing, re-siding, and siding for use groups R-3, R-4, and R-5 is a flat fee of \$75.00. All other use groups the fee is \$20.00 per thousand of estimated cost.
- (8) Fees for retaining walls over 4 feet in height (measured from bottom of footing to top of finished wall) shall be \$150.00 for residential structures less than 550 square feet; the fee shall be \$250.00 for residential structures over 550 square feet; the fee for all other use groups shall be \$30.00 per cubic foot over 1,000 of actual construction cost.

Section 2. Chapter 9A-3(b)(3) shall be amended as follows (deletions are noted thusly; additions are noted thusly:

- 3. Certificates and other permits:
- (a) The fee for demolition shall be \$100.00 for each story of the structure to be demolished \$200.00 for one- and two-family structures. The fee for demolition shall be \$30.00 per each \$1,000.00 of actual construction cost provided the minimum fee shall be \$250.00.

The owner of the building to be demolished or person applying for a demolition permit shall provide a cash or paper bond in an amount one and one-half times the estimated cost of the demolition, clearing and filling in of the site which shall require the completion of the work, and the clearing and filling in of the site and shall protect and indemnify the borough against loss or damage; upon satisfactory completion of the work, the bond shall be returned.

- (b) The fee for a permit to move a building or structure from one lot to another or to a new location on the same lot shall be \$100.00 plus \$10.00 per each \$1,000.00 of the actual cost of the new foundation; the owner of the building to be moved or the person applying for the permit shall furnish a cash or paper bond in the amount of one and one-half times the cost of moving, filling and grading of the lot, and foundation construction which shall require the completion of the work and the restoration of the site; upon satisfactory completion of the work, the bond shall be returned.
- (c) The fee for a certificate of occupancy or approval shall be in the amount of 10 percent of the total construction permit fee.
- (d) The fee for a certificate of occupancy for a change of use group and certificate of continuing occupancy shall be \$100.00.

- (e) The fee for a temporary certificate of occupancy for each construction trailer for up to six months shall be \$100.00.
- (f) The fee for a permit to construct a sign shall be in the amount of \$2.00 \subsection \$3.00 per square foot surface area of the sign computed on one side only for double faced signs, provided that the minimum fee shall be \$35.00 \subsection 75.00.
- (g) The fee for a special event permit involving tents at local parks shall be \$50.00 per each tent up to ten tents and \$500.00 over ten tents.
- (h) (Reserved) The fee for temporary structures other than tents and trailers shall be \$200.00 each structure.
- (i) The fee for footing and foundation on any new building shall be \$100.00, 50 percent of which will be used for credit on the update.
- (i) The fee for sheds 200 square feet and over, over 10 feet in height, or any size with utilities attached shall be \$200.00.
- (k) The fee for gazebos and prefab pool houses without footing and foundation shall be \$200.00.
- (1) The fee for photovoltaic systems for one- and two-family structures shall be \$300.00.; the fee for all other use groups shall be \$30.00 per \$1,000 of actual construction cost
- (m) The fee for asbestos and lead abatement shall be \$200.00.

Section 3. Chapter 9A-3 (c) shall be established as follows (all text shall be new text):

- 1. Flemington Zoning Department fees shall be as follows:
- 2. The fee for a zoning permit shall be \$50.00 or as established under the Municipal Land Use Law, N.J.S.A. 40:55D et seq.
- (a) The fee for single family dwellings, including foundation location review, shall be \$125.00.
- Section 4. All sections of the Borough Code not amended hereunder shall remain in full force and effect.
- **Section 5.** All ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Section 6. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to this section, paragraph, subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.

Section 7. This ordinance shall take effect upon adoption and publication in the manner required by New Jersey general law.

5. ORDINANCE 2023-22 - AN ORDINANCE AMENDING CHAPTER 7A: TITLED PARKING REGULATIONS OF THE BOROUGH OF FLEMINGTON

WHEREAS, traffic and parking regulations for the Borough of Flemington are contained in Chapter 7A and Chapter 7 of the municipal code thereof; and

WHEREAS, the Borough Council wishes to create a new Section 7A-20 in the aforementioned Chapter concerning compact cars and a companion section in Chapter 7 concerning the same;

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Flemington, in the County of Hunterdon, State of New Jersey, that a new section to Chapter 7A shall be created at Section 7A-20 and shall be entitled Schedule XX: Compact Cars and a new section to Chapter 7 shall be created at Section 7-5B entitled "Designated Compact Cars Zones":

SECTION I.

Section 7A-20 is hereby created and entitled "Schedule XX: Compact Cars" and shall consist of entirely new text as follows:

In accordance with the provisions of Section 7-5B, the following parking zone shall be utilized on by "compact cars" as defined in the U.S. Code of Federal Regulations as vehicles having between 100-109 cubic feet of combined passenger and cargo volume, and are between 161 and 187 inches long.

SCHEDULE XX:

COMPACT CARS

SECTION II.

Section 7-5B is hereby created and entitled "Designated Compact Car Zones" and shall consist of entirely new text as follows:

William Street from a point 57 feet north of the northerly curb line of William Street projected to a point 71 feet north thereof.

SECTION III. If any part of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of the ordinance.

SECTION IV. Should any section, paragraph, sentence, or clause of this ordinance be declared unconstitutional or invalid for any reasons, the remaining portions of this ordinance shall not be affected thereby and shall remain in full force and effect and, to this end, the provisions of this ordinance are hereby declared severable.

SECTION V. This ordinance shall take effect upon adoption and publication in the manner prescribed by New Jersey general law.
