# **BUSINESS AND COMMERCIAL PROPERTIES**

Each **building owner and all tenants** are required, per sections 8-10 thru 8-15 of the Flemington Borough Fire Prevention Code, to **register** with the Borough Fire Marshal annually.

When registering a new business, an annual registration and inspection fee, as determined by square footage, is required and will be invoiced at that time and at the beginning of each year after. Late payments <u>WILL</u> result in a penalty being issued.

A Continued Certificate of Occupancy (CCO) and Fire Inspection is mandatory (NJ State Statute) prior to **rental or re-rental** of <u>ALL</u> commercial properties.

Failure to comply with any of the Registration requirements and Inspections <u>will</u> result in a summons to appear in Municipal Court and may result in fines of \$500.00 per unit.
