- STATE STATUTE REQUIRES THAT ALL DOGS AND CATS 6 MONTHS OR OLDER BE LICENSED AND HAVE A CURRENT TAG AFFIXED TO COLLAR OR HARNESS
EXCEPTIONS—DOGS USED AS GUIDES FOR BLIND PERSONS AND COMMONLY KNOWN AS SEEING EYE DOGS SHALL BE LICENSED IN THE SAME MANNER AS OTHER DOGS, EXCEPT THAT THE OWNER OR KEEPER SHALL NOT BE REQUIRED TO PAY ANY FEE
- ALL DOG AND CAT LICENSES EXPIRE ON DECEMBER 31 EACH YEAR, LATE FEE TAKES EFFECT FEB 1ST
- THE RABIES VACCINATION MUST BE GOOD THROUGH OCTOBER 31ST OF THE ISSUING YEAR.
- NO DOGS ARE PERMITTED TO RUN AT LARGE—OWNERS WILL BE SUBJECT TO A FINE
- LICENSE MUST BE ISSUED IN THE NAME OF AN ADULT MEMBER OF THE HOUSEHOLD
- A FREE RABIES CLINIC IS HELD ANNUALLY
- RETURN THIS APPLICATION WITH A SELF-ADDRESSED STAMPED ENVELOPE, ALONG WITH YOUR CHECK OR MONEY ORDER MADE PAYABLE TO THE BOROUGH OF FLEMINGTON, IN THE APPROPRIATE AMOUNT
